Treasurer's Report: The Treasurer's report was presented. The balance of all funds is \$742,001.59.

Clerk's Report: The Clerk has just been notified that Michigan will not have to recount election ballots.

Firemen's Report: The Department has had three fire runs. The new fire truck is scheduled to be ready the first week of January.

Grounds and Park Report: It is winter and not much is happening.

Old Business: The permit for work to be done at Dunbar Park is being worked on.

Rob Laitinen is drawing up some sketches on expanding the parking lot.

Old Business: The Eastern U.P. Regional Planning & Development Commission is asking for us to participate in the Eastern U.P. Regional Trails Consortium. Mike Pins has volunteered to be our contact person.
