MINUTES OF REGULAR MEETING HELD ON NOVEMBER 9, 2017

The regular meeting of the Bruce Township Board was held on November 9, 2017 at the Bruce Township Hall with board members LaJoie, Marsh, Pins, Sawyers and Rogers present. Also in attendance were two township residents. The Supervisor called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

Public Comments: Questions were asked about taxes and assessment card availability. The Supervisor will talk to the Assessor about this.

The minutes of the October 12, 2017 meeting were presented. Motion was made by Rogers, seconded by Pins to accept the minutes as presented. All were in favor, motion carried.

Motion was made by Pins, seconded by Rogers to pay the bills. Checks #9428 through #9463 were issued for a total of \$ 15,937.60. All were in favor, motion carried.

County Commissioner Report: Commissioner MacLean was not present.

Reports of Special Meetings: There was no report.

Zoning Administrator: There have been 19 permits issued.

Assessor Report: The Assessor was not present.

Planning Commission Report: Report under old business.

Treasurer's Report: The Treasurer's report was read. The balance of all funds is \$666,679.74.

Clerk's Report: There was no correspondence.

Firemen's Report: There was no report.

Grounds and Park Report: The dock has been brought in and the tables have been put away.

Old Business: An Ordinance #2-2017 was presented regarding Medical Marijuana Facilities. Motion was made by Pins, seconded by Rogers to authorize and adopt Ordinance #2-2017 regarding Medical Marijuana Facilities. Roll Call vote: Yeas, Marsh, LaJoie, Sawyers, Pins and Rogers. Nays: 0. Resolution adopted.

An Amendment #- 13 -2017 to Zoning Ordinance #. 01-2004 was presented as revised. #28.304 (a) Single family dwellings shall have a minimum of four hundred (400) square feet of floor area. Motion was made by Pins, seconded by Rogers to adopt Amendment #13 to Zoning Ordinance #01-2004. Roll Call vote: Rogers, Pins, Sawyers and Marsh. Nay: LaJoie. Resolution adopted.

New Business: December Board of Review will be held on Monday, December 11 at 7:00 p.m.

A letter was read from Attorney, Charles Palmer in regards to the violation of the Bruce Township Nuisance Ordinance by Brian Marken. Mr. Marken has agreed to the entry of a Consent Judgement.

Public Comments: Discussion was held on the contents of the newsletter and the cost of publishing it.

Motion was made by Rogers, seconded by Pins to adjourn the meeting. All were in favor, motion carried. The Supervisor adjourned the meeting at 7:40 p.m.
