MINUTES OF REGULAR MEETING ON JANUARY 10, 2019

The regular meeting of the Bruce Township Board was held on January 10, 2019 at the Bruce Township Hall with board members LaJoie, Sawyers, Marsh, Rogers and Pins present. The Supervisor called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

Public Comments: There were no comments:

The minutes of the January 10, 2019 were presented. Motion was made by Marsh, seconded by LaJoie to accept the minutes as presented. All were in favor, motion carried.

Motion was made by Pins, seconded by LaJoie to pay the bills. All were in favor, motion carried.

The Supervisor was at a Chippewa County Road Commission meeting. Shunk Rd between 6 Mile Rd and 9 Mile Rd is scheduled for work in 2021.

Planning Commission: There was no report.

Zoning Report: There was no report.

Assessors Report: There was no report.

The Treasurer's Report: The Treasurer's Report was read. The balance of all funds is \$641,174.93.

Clerk's Report: There was no correspondence.

Grounds and Park: There is not much that can be done until Spring.

Old Business: There was a change in the Contract with the Sault Ambulance to service both sides of 9 Mile Rd. Motion was made by Rogers, seconded by Pins to accept the changes. Roll Call Vote: Yeas, Marsh, Sawyers, LaJoie, Pins and Rogers. Nays, 0.

The Board of Review members are up for election. Motion was made by Marsh, seconded by Rogers to appoint Angie Bonee, Carolyn Person, Melvin Van Luvén and Ward Pulfrey as an alternate Motion carried. There will be Board of Review training in Brimley. Motion was made by LaJoie, seconded by Pins to send the Board of Review members for training. All were in favor, motion carried.

Discussion was held on the new marijuana laws. This ordinance may be changed by vote of the township voters.

Land Division was presented for Frank and Ellen Quinlan, parcel # 002 119 001-00 on 6614 E. 15 Mile Rd. Motion was made by Lajoie and seconded by Rogers to accept the land division. All were in favor, motion carried.

The township office has been getting some upgrades and computer work done. Dave Petrangelo has did a great job. Motion was made by Rogers, seconded by Pins to accept the bid for \$945.00. All were in favor, motion carried.

Public Comments: Discussion was held on Cemetery.
