

TOWNSHIP OF BRUCE
MINUTES OF REGULAR MEETING HELD ON MAY 10, 2018

The regular meeting of the Bruce Township Board was held on May 10, 2018 at the Bruce Township Hall with board members Sawyers, LaJoie, Rogers, Pins and Marsh present.

Absent none. Also present were 2 township residents. The Superintendent called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

Public Comments: There were no comments.

The minutes of the April 12, 2018 were presented. Motion was made by Pins, seconded by seconded by Rogers to accept the minutes as presented. All were in favor, motion carried.

Motion was made by Rogers, seconded Pins to pay the bills. Checks # 9612 through # 9641 were issued for a total of \$ 17,996.56. All were in favor, motion carried.

County Commissioner Report: Commissioner MacLean was not present.

Reports of Special Meetings: The Supervisor attended MTA State Convention in Traverse City.

Zoning Administrator: There have been 4 permits issued this month.

Assessor's Report: They have been checking new Construction. They are visiting commercial and agriculture land.

Planning Commission: There has been no meeting.

Treasurer's Report: Treasurer's report was read. The balance of all funds is \$915,409.13.

Clerk's Report: There was no correspondence.

Old Business: An agreement between Bruce Township and CCI Systems, Inc. is to identify and outline understandings concerning wireless infrastructure and other facilities that

Bruce Township will provide CCI Systems. Motion was made by Pins, seconded by Roger to accept the agreement. Roll call vote, Yeas, Marsh, Sawyers, Pins, LaJoie and Rogers.

Nays, 0. Motion carried.

A proposal was presented by Payne and Dolan to pave the Parking Lot and around the Fire Hall for \$88,645.00. Motion was made by Rogers, seconded by Pins to accept the proposal with Payne and Dolan's bid for \$88,645.00. Roll call vote, Yeas: Rogers, Marsh, Pins, Sawyers and LaJoie. Nays- 0. Motion carried.

We will be getting brine for the roads around the first week in June.

The cemetery is being cleaned up and the road is being fixed.

Road Improvement & Maintenance Proposal Millage, if approved by the voters, permits the Township to levy 2.5 mills to renew and fully restore the millage which was previously

approved by the electors in 2014 to fund road improvements and maintenance with in the township for 4 years beginning in 2018. The estimate of revenue the Township will collect if this millage is approved and levied in 2018 is \$18,255.00. Motion was made LaJoie seconded by Marsh to pass a resolution to renew the Road millage proposal on the

August 6, 2018 ballot.

Roll call vote, Yeas: LaJoie, Sawyers, Marsh, Rogers and Pins. Nays, 0. Motion passed.

The Supervisor will call Robinson Fence Company about getting a fence for the ball field.

Discussion was held about doing a newsletter in June.

The web site is in progress.

Discussion was held to have an internet link through BS&A for our property cards. The website is free but we would pay a yearly fee. This was tabled until next month.

Motion was made by Rogers, seconded by Pins to adjourn the meeting. All were in favor, motion carried. The Supervisor adjourned the meeting ay 8:55p.m.
