Jeff Moran will be shoveling the sidewalks for the winter months.


Discussion was held on expanding the parking lot. Motion was made by Rogers, seconded by Pins to get some bids for Spring. All were in favor, motion carried.

The BOR for clerical errors will be held on December 13, 2016 at 7:00 p.m.


The Township Officers will remain the same. The Clerk swore the Officers in for the next term.
