
The Chippewa County Road Commission presented an agreement to improve Scenic Drive from the south end of the new DNR boat ramp proceeding northerly for a distance of approximately 1.38 miles. Said improvements to consist of HMA 13A Paving, Gravel Shoulders and Pavement Markings. The total cost to the Township is \$81,600.00. Motion was made by Rogers, seconded by Marsh to enter into an agreement with Chippewa County Road Commission to improve Scenic Drive from the south end at the new DNR boat launch proceeding northerly for a distance of 1.38 miles. The total cost to the Township shall be \$81,600.00. Roll call vote: Yeast: Rogers, Pins, Sawyers and Marsh. Obstain: LaJoie. Motion carried.

At the Bruce Township meeting held on March 10, 2016, a public meeting was held on Budgeting and Truth in Taxation. Motion was made by Pins, seconded by Marsh to accept the resolution to levy the following millages for 2016 to be levied on property in Bruce Township as set forth in the "2016 TAX REQUEST". Allocated, operating, 1.6461, Voted road improvement, 2.4955. Total operating millage, 4.1416. Roll call vote: LaJoie, Marsh, Sawyers, Pins and Rogers. Yeas, 0. Resolution adopted.


