The minutes of the March 9, 2017 meeting, Marsh 16, 2017 meeting and March 27, 2017 meeting were presented. Motion was made by Rogers, seconded by Pins to accept the minutes as presented. All were in favor, motion carried.

Motion was made by Pins, seconded by Rogers to pay the bills. Checks # 9170 through # 9208 were issued for a total of \$ 26,772.36. All were in favor, motion carried.

The General Fund Budget was adjusted. Motion was made by Sawyers, seconded by Marsh to increase Legal Fees #802 by \$30.00 and decrease #694 Contingency by \$30.00. Motion carried.

The Zoning Fund Budget was adjusted. Motion was made by Sawyers, seconded by Rogers to increase #702, Salary's by \$350.00 and decrease # 694, Contingency by \$350.00. Motion carried.

Motion was made by Sawyers, seconded by Marsh to increase #715, FICA by \$20.00 and to decrease #694, Contingency by \$20.00. Motion carried.

Motion was made by Rogers, seconded by Marsh to adjourn the meeting.
